READ CAREFULLY - THIS AFFECTS YOUR LEGAL RIGHTS

This agreement is myself and NazTfloaT LLC (hereafter the “Company”) of Bentonville, Arkansas for the rental and/or use of the equipment and services of the Company, in exchange for the use and services, I agree to the following:

AGREEMENT TO FOLLOW DIRECTIONS. I agree to observe and obey all posted rules and warnings, and further agree to follow any oral instructions or directions given by the Company, or its employees, representatives or agents.

ASSUMPTION OF THE RISKS AND RELEASE. I recognize that there are certain inherent risks associated with the activities offered by the Company, including but not limited to Onewheel electric skateboard use and operation and I assume full responsibility for personal injury to myself or others and further release and discharge the Company for injury, loss or damage that may occur while using any equipment rented from the Company – REGARDLESS OF ITS CONDITION.

INDEMNIFICATION. I agree to indemnify and defend the Company against all claims, causes of action, damages, judgments, costs or expenses, including attorney fees and other litigation costs, or any other remedy for any injury to myself, my property, my death, however caused, arising out of my use of any equipment rented or purchased from the Company, or which may in any way arise from my rental and use of the equipment.

_____ I understand that equipment and safety devices are not [are] provided for my use (such as pads and helmet).

_____ I agree that I will be solely responsible for proper use of safety and other equipment and procedures.

_____ It is my responsibility to inspect all equipment.

_____ I (renters) am responsible for ensuring all equipment is properly used and attached. I also agree to not operate the equipment under the influence of drugs or alcohol.

FEES AND COSTS. I agree to pay for all damages to the equipment rented caused by any negligent, reckless, or willful actions.

_____ It is my responsibility to inspect all equipment.

_____ I hereby agree that if equipment rented from the Company is damaged, lost or misplaced that I will pay for the losses or damages

_____ I agree that if the Company incurs any cost associated with recovery of payment for damages or losses (such as court costs, collection costs and/or attorney costs) that I will reimburse or pay the Company for these costs as well as the cost of the damaged items.

_____ It is solely the discretion of the Company to determine if damaged equipment will be repaired or replaced at the renter's expense.

_____ I agree that the Company can charge my account or credit card on submitted at time of rental for daily late fees for any rental not returned on the due date with or without my consent for _____ consecutive days.

_____ I agree that the Company can charge the full retail price of any rental product not returned within _____-days of the expiration of the rental term without my consent.

APPLICABLE LAW. Any legal or equitable claim that may arise from participation in the above shall be resolved under Arkansas law.

NO DURESS. I agree and acknowledge that I am under no pressure or duress to sign this Agreement and that I have been given a reasonable opportunity to review it before signing. I further agree and acknowledge that I am free to have my own legal counsel review this Agreement if I so desire.

ENFORCEABILITY. The invalidity or unenforceability of any provision of this Agreement, shall not affect the validity or enforceability of any other provision of this Agreement or its application and such invalid or unenforceable provision shall be deemed not to be a part of this Agreement.
